OFFICE MEMORANDUM

Subject: Verification of scholarship applications of students with disabilities of Department of Empowerment of Persons with Disabilities received online on National Scholarship Portal

As you are aware that the Department of Empowerment of Persons with Disabilities is implementing three Scholarship Schemes for Students with Disabilities, namely, (a) Pre-matric Scholarship (b) Post-matric Scholarship; and (c) Scholarship for Top Class Education through National Scholarship Portal (NSP). The last date for fresh and renewal applications of all the three scholarship schemes has been extended upto 31st October, 2017.

I hope the work relating to verification of scholarship applications is going on smoothly. The delay in verification of applications will deprive these students of the benefits of scholarship. As you are aware, in case the scholarship amount is less than Rs.50,000/-, supporting documents are to be kept in safe custody of Head of School/Institution. However, the supporting documents are to be mandatorily uploaded on the portal if the scholarships amount exceeds Rs.50,000/- for any candidate. It has come to our notice that some fake scholarship applications have been verified by the institute and the state nodal officer without uploading of any document in the portal. It is once again reiterated that it will be the sole responsibility of the Head of School/Institution/State Nodal Officer to satisfy himself/herself with the documents submitted by the students before he/she verifies the scholarship applications.

The State Nodal Officer should ensure that Digital Signature Certificate (DSC) of those DSC has expired/going to expire may take necessary action to procure DSC well in time for signing payment files in the PFMS portal.
