



## DEPARTMENT OF HIGHER EDUCATION SUBMISSION OF ONLINE APPLICATIONS FOR AWARD OF "MEDHABRUTI" FOR THE YEAR 2019-20- FRESH

59: The Higher Education Department, Government of Odisha invites online application for award of Senior Merit/P.G. Merit/Technical & Professional Merit (Fresh) for the year 2019-20 to meritorious students of Odisha for pursuing general courses (i.e. +3 & PG Courses) and Technical & Professional Courses in Non-SAMS institutions (i.e. CBSE/SE affiliated School, Universities/ Management/Engineering & Technical institutions) inside and outside Odisha. Students studying in colleges under SAMS (Student Academic Management System) need not apply for scholarship online separately as the database is available in the SAMS portal. The detail guidelines along with eligible courses are available at Medhabruti web portal of Higher Education Department under URI [www.medhabruti.org](http://www.medhabruti.org). The different categories of merit, number, rate, duration and courses applicable for scholarship are given in a tabular form.

Sr. No.	Category of Merit	Number	Rate of Scholarship	Duration of Scholarship	Courses applicable
01	Sr. Merit	3,000	5,000/-	03 Years	Students pursuing +3 Degree Courses (BA/B.Sc./B.Com) and courses such as BBA/BCA/BJMC etc. having duration of 03 years.
02	P. G. Merit	1,500	10,000/-	02 Years	Students pursuing P.G. courses in Arts / Commerce / Science / other Post Graduate courses which are of non-professional in nature and admission to such P.G. course is Degree in Arts / Science / Commerce
03	Technical & Professional Merit	10,000	10,000/-	As per course duration	Students pursuing only Undergraduate Professional courses mentioned in Appendix-II of the guidelines are eligible under this head.

(A.B.: 1) The students who have availed Sr. Merit, P.G. Merit and Technical & Professional Merit for the respective category in the previous selection year (s) need not apply again under the same (fresh) category as they are covered under Renewal scholarship in current academic session.

(2) Aadhaar is made mandatory for availing scholarship. Please provide correct Aadhaar number of self in the Online Application form. In case it is found that Aadhaar number provided by the student is wrong or is not his/her, the application is liable to be rejected.

(3) Applicants have to be very careful while furnishing their Bank Account information in the specified box of the Online Application. Any wrong entry or mismatch of the SB Account and IFSC, this Department will not be held responsible for mis-credit/no credit.

### ELIGIBILITY CONDITIONS

student must be permanent resident of the State of Odisha.

The income of the parents of the student from all sources should not exceed Rs.5.00 lakh per annum.

The student must have secured minimum 60% marks in the last qualifying examination for applying scholarship under different categories of merit.

Students shall apply for medhabruti only in the First year of joining (1st yr. of the course undertaken).

### DOCUMENTS TO BE UPLOADED

Resident certificate to be issued by the competent authority i.e. Tahasildar/Addl. Tahasildar.

Proof of annual income to be issued by the competent authority i.e. the Revenue Officer not below the rank of Tahasildar or Addl. Tahasildar.

Mark sheets and Certificate of last qualifying examination as required for different categories of merit.

Bank account details of the student concerned (First page of bank account containing account number and IFSC).

College ID card issued by concerned authority. While in the absence of the same, the student may provide Admission Receipt/Library card/Letter of Undertaking from concerned college authority (any one).

Aadhaar card of concerned student.

### IMPORTANT INSTRUCTIONS

Students are advised to go through the notice "Bank accounts related advisory" and FAQs in the Medhabruti home page carefully before making application for hassle-free transactions and keep applicant copy for future reference. District wise merit list will be prepared for e-Medhabruti scholarship for the year 2019-20 proportionately basing on the strength of population of concerned district. If students are not available as per ratio in backward and tribal dominated districts, the surplus quota will be distributed among other remaining districts proportionately.

Eligible students of Non-SAMS colleges are advised to apply online by accessing [www.medhabruti.org](http://www.medhabruti.org). Only online application under the scheme will be accepted and no request for accepting OFFLINE applications will be entertained. While applying online, students should upload the scanned copies of relevant documents.

After applying online, students are required to submit the printed copy of online application along with relevant documents in the college for validation at the level of Principal.

Students of SAMS who secured 60% marks or more will be displayed in the concerned colleges Administrator login. The Administrator needs to upload the required documents after collecting the same from eligible students.

Applicants are advised to be very careful to mention the accurate Bank Account related information in the specified box of the online application. In case of any wrong entry or mismatch of the SB Account & IFSC, this Department will not be held responsible for miscredit/No credit.

Incomplete or wrongly filled up application or application without essential documents shall be summarily rejected.

The applicants Mobile No. and functional e-mail address must be used for submission of the online application.

The status of the application will be informed to the applicant's mobile number and e-mail provided in the online application.

**SUBMISSION OF MORE THAN ONE APPLICATION WILL BE SUMMARILY REJECTED.** Please ensure that all aspects of the application are correct before the submission. No claims shall be entertained in case of incomplete or non-submitted application.

Aadhaar authentication in case of SAMS and Non-SAMS (Fresh) and all renewal students' data record are to be verified by the concerned college Principal/Institution at the time of validation.

Online validation at the level of Institution Head/Principal of Institution is mandatory for release of scholarship amount.
