Rama Devi Women's University Standard and Procedures for award of Ph. D. Degree (2nd Amendment) Regulation, 2022

Rama Devi Women's University hereby makes the following amendments to Rama Devi Women's University Standards and Procedures for award of Ph. D. Degree Regulation, 2021. These Regulations may be called as "Rama Devi Women's University Standards and Procedures for award of Ph.D. Degree (2nd Amendment) Regulation, 2022". They shall come into force from the date of its official publication.

The Clause 7.2 of the RDWU Standards and Procedures for award of Ph.D. Degree Regulations, 2022 shall be read as:

7.2: Only full time regular faculty member of RDWU / its affiliated institute with Ph.D. Degree shall be the Ph.D. Supervisor as per recommendation of the DRC, if he /she is eligible as per other criteria. The recognised supervisor can take scholar(s) up to the time of his/ her superannuation under the university.
